#### 1. Personal Data We Process

#### **A. Privacy Commitment**

Qualigraf Canada takes your privacy seriously. We process personal data about you when you use our website, our services, or when you provide this information to us directly.

For the purposes of the Personal Information Protection and Electronic Documents Act (PIPEDA) and relevant provincial legislation, Qualigraf Canada is the data controller.

#### A. From Website Visitors

- 1. Full name

- 5. Other information you provide via contact forms
- 6. Location data
- 7. Information about your activity on our website
- 8. IP address
- 9. Browser and device type

## 3. Special or Sensitive Data

#### A. Minors

Our website and services are not intended for individuals under 13 years of age and we do not knowingly collect data from minors, unless consent is provided by a parent or legal guardian. We encourage parents to monitor their children's internet use.

#### **B. If You Suspect an Error**

If you believe we have collected data from a minor without consent, please contact us at info@qualigraf.com. We will promptly delete such data.

## 4. Why and How Long We Retain Data

#### A. Purposes

- 1. To contact you when necessary for service delivery.
- 2. To send you tips related to meeting organization.
- 3. To send newsletters if you've subscribed.



- 4. To allow demo or trial account requests via the website.
- 5. To respond to inquiries submitted through the contact form.
- 6. To analyze website usage and improve our services.

#### **B. Retention Periods**

- 1. Website form submissions are deleted within 60 days.
- 2. Newsletter subscription data is deleted when a user unsubscribes.
- 3. CRM data is retained as long as relevant for ongoing or potential business relationships. For specific retention inquiries, email info@qualigraf.com.

## 5. Third-Party Processors

#### A. We may share/store your data with the following:

- Email and marketing platforms such as HubSpot or Inboxify (or other similar platforms) for newsletters and tips. We maintain a data processing agreement with these providers.
- 2. Form data is stored in our website CMS (e.g., WordPress) and CRM to ensure continuity of service and timely responses. This backup is deleted within 6 months.
- 3. These processors are contractually obligated to maintain the same level of data protection we uphold.

#### 6. Website Use and Cookies



#### A. Cookies

#### Qualigraf Canada uses cookies:

- 1. Functional cookies: Ensure the website operates properly (e.g., remembering preferences).
- 2. Analytical cookies: Track website usage patterns (e.g., via Google Analytics).
- 3. Tracking cookies: May be set by third parties to deliver personalized ads based on browsing behavior.

#### B. If You Suspect an Error

You can control cookie settings on your first website visit. Non-essential cookies are only placed after your active consent. You can change preferences at any time.

## 7. Access, Modify, or Delete Your Data
